

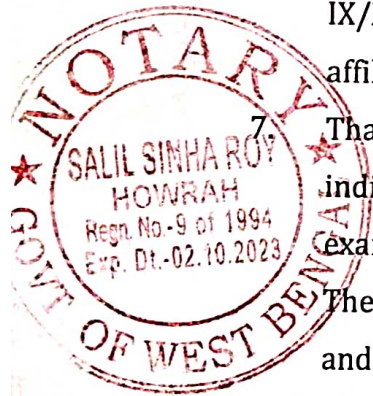

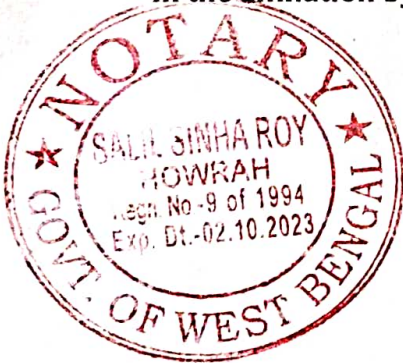


1. That Birendra Kumar Das Educational And Charitable Trust is a registered society or trust under the Section 60 and Rule 69.
2. That the Birendra Kumar Das Educational And Charitable Trust is a of Non-Proprietary Character.
3. That the school is being run as a community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
4. That no part of income from the institution is being and will be diverted to any individual in the Society /Trust /Company /School Management Committee or to any other person/ entity. The saving, if any, after meeting the recurring and non recurring expenditure and contributions to developmental depreciation and contingency funds will be further utilise for promoting the school and extending the cause of education in the same school only.
5. That the school is not paying any charges towards using name, moto, logo or any other non academic activities to any other institution organisation or body.
6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent / Manager of the school have individually gone through the provisions content in the affiliation and examination byelaws and the circular issued by the board from time to time . The school under takes to abide by the provisions contained in the affiliation and examination byelaws issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc. with respect to the school and staff of the school.
